Mid-State Tool Insurance

Mid-State provides \$7,500 tool insurance (\$50.00 deductible) to all mechanics and body men who provide a complete tool list and update the list regularly. This coverage is not provided to anyone who has not submitted an itemized list of their tools for the company to have on file. Mechanics have the option to waive coverage if they do not want to be included.

Additional insurance may be purchased at the cost of \$.60 per each additional \$100. A payroll deduction will be established to pay for this additional insurance on a per pay check basis.

For example: If you have a total of \$16,000 in tools...
 $\$16,000 - \$7,500$ (Mid-State Provides) = \$8,500 Additional Coverage.
 $\$8,500 \times \$.60 = \$5,100$.
 $\$5,100 \div \$100 = \$51.00$ premium per year
 $\$51.00 \div 26$ paychecks = \$1.96 per pay check deduction.

Changes need to be made annually to increase or decrease coverage, drop the coverage, or sign up for coverage. A notice will be given at the time that the policy is up for renewal.
